ANNEXURE 'A'

The bids should be valid for a period of 90 days from the date of its opening.

II. A non refundable tender fee of a fixed amount ₹25% should be deposited in the form of a demand draft from any nationalized bank in favour of "The Principal, Bhaskaracharya College of Applied Sciences" along with the bid enclosed in the outermost envelope (C). Name, address and telephone number of the bidder should be clearly written on the backside of the Demand Draft.

III. A refundable Earnest Money Deposit of a fixed amount ₹5000/- should be deposited in the form of a bank guarantee/ single demand draft from any nationalized bank in favour of "The Principal, Bhaskaracharya College of Applied Sciences" along with the bid enclosed in the outermost envelope (C). Name, address and telephone number of the bidder should be clearly written on the backside of the Demand Draft. Tenders without E.M.D. and Tender fee will not be considered.

IV. Single bid for whole lot may be quoted at the prescribed place in the price bid otherwise tender shall not be accepted. No individual item shall be sold on the basis of rates quoted for that item. The amount for the whole lot shall be considered to decide the highest bid. The highest bidder for a lot will be the successful vendor for same.

V. The bid security of the successful vendor will be treated as the interest free performance security for the contract. GFR 2005 will be applicable in regard of bid and the performance security deposited. The amount will be adjusted at the time of full disbursement of payment by the successful bidder.

VI. The successful vendor has to pay the remaining amount in the form similar to EMD within 3 working days after being informed regarding its bid success. The items should also be taken immediately after full and final payment at its own risk, cost and responsibility within office hours. If the same is not taken within stipulated time, the firm shall have no right to claim on the material.

VII. Only the person authorized by the purchaser, in writing, will be allowed to take delivery. No loading shall be allowed in holiday, Saturday & Sunday. No picking, choosing or sorting will be allowed in the premises for the

VIII. The bid security of the successful vendor who withdraws or fails to execute the order shall be deemed to forfeit and no correspondence will be made with it in this regard. The firm will be blacklisted for a minimum period of One year.
